Vouchers will be digitally loaded to your membership accounts - no physical vouchers necessary! You will be able to login to your membership account to check the number of vouchers available in your account. For dual memberships, the vouchers are shared between both members.

WHAT WILL HAPPEN TO MY CURRENT MEMBERSHIP?

Your current membership benefits will remain unchanged through your expiration date. The deadline for renewing memberships at the current benefit program is August 31, 2022.
